Mr. Yashwant R Gamare and Mrs. Nisha Y Gamare availed Housing Loan facility from Indian Bank, Kalina Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Yashwant R Gamare and Mrs. Nisha Y Gamare failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 27/07/2022 Under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr. Yashwant R Gamare and Mrs. Nisha Y Gamare liable to the Bank to pay the amount due to the tune of Rs. 18,82,065.00 (Rupees Eighteen lac Eighty Two Thousand and Sixty Five only) as on 27/07/2022 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 27/07/2022.

As Mr. Yashwant R Gamare and Mrs. Nisha Y Gamare failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 31/01/2023 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance.
