Mr Mahesh Karkar availed Housing loan facility from Indian Bank, Dindoshi Branch, and the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr Mahesh Karkar failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 05.11.2022 Under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) Mr Mahesh Karkar liable to the Bank to pay the amount due to the tune of Rs. 27,64,863.30/- (Rupees Twenty Seven lakhs Sixty Four thousand Eight Hundred Sixty three rupees and thirty paise only) as on 05.11.2022 with further interest, costs, other charges and expenses thereon. Mr Mahesh Karkar failed to make payment despite Demand Notice. The Authorized Officer took possession of the schedule mentioned properties under the Act on 24.01.2023 after complying with all legal formalities. As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 24.04.2026 Rs. 39,58,593/- (Rupees Thirty Nine Lakhs Fifty Eight Thousand Five Hundred Ninty Three only) with further interest, costs, other charges and expenses thereon from 24.04.2026.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense on 13.05.2026 between 10.00 am to 4.00 pm.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

Further, they are requested to upload requisite KYC documents.
