M/S Riddhi Siddhi Engineering Works(Formerly Riddhi Siddhi Hardware) failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 31.01.2022 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/S Riddhi Siddhi Engineering Works(Formerly Riddhi Siddhi Hardware) , Mr. Dhiraj Anil Krishnan (Proprietor& Gaurantor), Vijaylakshmi Anil Krishnan(Mortgagor/Gaurantor), Mr. Amit R Handa(Gaurantor)liable to the Bank to pay the amount due to the tune of Rs.27,36,172/- (Rupees Twenty Seven Lakh Thirty Six Thousand One hundred and Seventy Two only) as on 28.01.2022 with further interest, costs, other charges and expenses thereon. All of you failed to make payment despite Demand Notice dated 31.01.2022.

All of you have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21.11.2022 after complying with all legal formalities.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement )Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **15 days** notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **24.04.2026** is **Rs.53,02,487/- (Rupees Fifty Three lakh Two Thousand Four Hundred Eighty Seven only)** with further interest, costs, other charges and expenses thereon from **24.04.2026**.
