INDIA bloc rift: Kanimozhi asks Lok Sabha Speaker for change in seat for DMK MPs

The first fallout of the 2026 edition of Assembly elections came with DMK MP Kanimozhi writing to Lok Sabha Speaker Om Birla to change the seating arrangements in the Parliament so that they don't have to sit near the Congress MPs.

"I write to respectfully request suitable changes in the seating arrangement of the MP belonging to the DMK in the Lok Sabha. In view of the changed political circumstances and as our



appropriate for our Members to continue occupying the present seating arrangement alongside them in the House," she said in a letter reportedly dated 7 May.

"I therefore request your good office to kindly make the necessary arrangements for the Hon'ble Members of the DMK Parliamentary Party to be allotted separate seating, enabling them to effectively discharge their responsibilities in the August House. I shall be grateful for your kind consideration in this regard," she wrote.
