

India, Pakistan send delegates for week-long funeral Khamenei's farewell starts

Dubai: New Delhi: The body of Ayatollah Ali Khamenei lay in state in a vast hall in Tehran on Friday as clerics, officials, foreign dignitaries and other mourners paid their respects to Iran's late Supreme Leader, slain by US and Israeli bombs.

Iran is staging a week of mass funeral processions for Khamenei, whose 37-year reign was brought to an end in February by the first strikes of the war, in a show of public devotion to the Islamic Republic's theocratic state and revolutionary zeal.

India had a considerable presence in Tehran on Friday as the week-long funeral ceremonies began.

While India was officially represented by minister of state in the external affairs ministry Pabitra Margherita and Bihar governor Lt. Gen. (ret'd) Syed Ata Hasnain, at least two political parties sent their representatives to Tehran and an all-region group also flew to the Iranian capital to be part of the ceremonies.

A week after Iran had officially invited Prime Minister Narendra Modi to attend the funeral, India on Thursday announced that Margherita and Hasnain will attend the funeral. The external affairs ministry said, "The high-level representation in the ceremony underscores the impor-

ance of civilisational ties, including people-to-people connection, between the two countries, providing a robust foundation to political and economic engagements."

The Congress sent former external affairs minister Salman Khurshid as its representative. The BJP was the only other party among the several that received invites and Mehbooba Mufti travelled to Tehran on Friday. A multi-faith group of religious leaders was also present.

In a social media post, said it was "an honour" to be part of the funeral ceremony of His Eminence Grand Ayatollah Seyyed Ali Khamenei in Tehran today, along with MoS External Affairs @PmargheritaBJP. Also extended deepest condolences to the families and to the country's most pious and devout who lost their lives in the recent conflict," Hasnain said.

late on Thursday to a throng of onlookers, waving and beating their heads in time to a sung lament as flowers were thrown from the bier into the crowd. On Friday, the coffin—and those of family members killed with him—was laid in state in the great prayer hall built to honour his predecessor, Ayatollah Ruhollah Khomeini.

A black turban, worn by clerics claiming descent from Islam's Prophet Mohammad, lay on the coffin in a folded chequered scarf, a symbol in Iran of militant revolutionary ideas and solidarity with Palestinians.

Support for the clerical leadership is paper thin, analysts say, and the new Supreme Leader, Khamenei's son Mojtahab Khamenei, has not been seen in any new image since being wounded in the strike that killed his father.

Representatives from Russia and China were expected to attend. Top Iraqi, Armenian and Pakistani politicians arrived in Tehran for the funeral.

Bibi-Trump call

Israeli Prime Minister Benjamin Netanyahu spoke with US President Donald Trump on Friday and the two leaders agreed to meet soon in the US, Netanyahu's office said.

The statement did not specify when the meeting would take place.

Venezuela President backs quake response

Catia la Mar, Venezuela: Venezuela's US-backed acting President Delcy Rodríguez on Thursday issued a fiery defence of her government's response to last week's devastating earthquakes.

She lashed out at critics who say authorities reacted too slowly, pushing back on suggestions that the true death toll is far higher than the government has acknowledged and rejecting accusations that the nation's shoddy constructed social housing exacerbated the disaster.

The government of Rodríguez has come under fire for what residents have described as a sluggish and hap-hazard response to the quakes. Residents of the hardest-hit state, La Guaira, have complained that the initial absence of a serious government search-and-rescue operation left them alone to scour for their loved ones with bare hands.

At a press conference in Caracas on Thursday, Rodríguez refused to accept criticism. She said, "We did not wait one day, two days or three days. We activated immediately. To politicise a humanitarian tragedy like this—when the Venezuelan government and its authorities have spared no effort, public, private, national, or international—is disgraceful." AP

6 killed in fresh Russian strikes

London: Russian attacks killed six people on Friday in three different areas of Ukraine, regional officials said.

A series of more than 50 strikes by drones, artillery and bombings killed three in southeastern Dnipropetrovsk region, including two near Nikopol, a town on the opposite bank of the Dniipro River from the Russian-held Zaporizhzhia nuclear power plant.

Two people were killed in a strike to the northeast on the city of Zaporizhzhia, a frequent recent target of deadly attacks, regional governor Oleksandr Hanzha said on Telegram.

And in the city of Sumy, near the Russian border, one person was killed when Russian forces launched glide bombs, regional governor Oleh Hryhorov said. Russian forces have long sought to build up a buffer zone in the region.

Rescue operation

Rescuers sifted through rubble in search for survivors in Kyiv on Friday as the Ukrainian capital observed a day of mourning, a day after a Russian missile and drone attack killed at least 30 people in the deadliest strike on the city this year.

Chinese EV demand

struggling to keep up with demand for new electric vehicles from China as drivers look to sidestep a fuel crisis that has led to long queues and soaring prices across much of Russia.

Escalating Ukrainian strikes on Russian energy infrastructure have squeezed gasoline and diesel supplies in recent weeks, prompting restrictions in most regions.

Retail gasoline prices in some areas have climbed to among the highest levels in the world, according to Reuters calculations.

Russia's vast distances, harsh climate, and limited charging network have curbed the growth of its EV market. But the mounting fuel challenges are leading some motorists to make the switch.

EV cars, which specialists in Chinese brands, is selling two to three EVs per day, compared with two to three a month just a few weeks ago, founder Yevgeny Zabelin told Reuters on Wednesday. Reuters

Delhi makes intent clear on Dhaka Teesta ties

New Delhi: The external affairs ministry on Friday said India would factor in related developments in the country's overall approach to the Teesta issue while maintaining that New Delhi's views on the Teesta River Comprehensive Management and Restoration Project have been conveyed to Bangladesh.

Ministry spokesperson Randhir Jaiswal was responding to a question at the briefing on China last week, pledging full support to the management of Teesta and other rivers in Bangladesh during Prime Minister Tarique Rahman's Beijing visit.

"India's development assistance for projects in Bangladesh is based on a mutually agreed roadmap, which is regularly reviewed. Our views on the Teesta River project have been previously conveyed to the Bangladesh side. We will factor all related development in our overall approach to the Teesta issue," Jaiswal said.

Of particular concern for India is Chinese involvement in a mega infrastructure project that requires large manpower near the Chicken's Neck Siliguri Corridor that connects the Northeast to the rest of the country.

Strong global 3,700 excess E Nino warning heat deaths

New Delhi: El Niño conditions in the tropical Pacific are expected to strengthen rapidly in the coming months, increasing the risk of heatwaves, droughts, heavy rainfall and other extreme weather events across many parts of the world, the World Meteorological Organisation (WMO) said on Friday.

The organisation's monthly "WMO Global Seasonal Climate Update" indicates a rapid development into a strong El Niño event during July-September this year.

El Niño is one of the three phases of the El Niño Southern Oscillation (ENSO), a climate phenomenon characterised by changes in sea temperatures along the central and eastern tropical Pacific Ocean, accompanied by fluctuations in the atmosphere overhead.

While El Niño is known to have a warming effect on the planet, its opposite phase, called La Niña, usually results in a cooling effect. ENSO also has a neutral phase.

In a statement, WMO secretary-general Celeste Saulo said: "El Niño conditions are already underway and are forecast to strengthen rapidly into a strong event as accurately anticipated by WMO forecasts. This will intensify the chances of drought and heavy rainfall and the risk of heatwaves on land and marine heatwaves in many regions of the world."

On June 12, the India Meteorological Department declared the onset of El Niño and said that it would strengthen further during the southwest monsoon.

El Niño typically lead to less rainfall in India. They were one of the key reasons why June, the country's a whole winter, saw a deficit of about 40 per cent, with central India worst affected with a deficit of 50.4 per cent. In its June 30 forecast, the IMD said the monthly average rainfall over India is expected to be below normal during July.

Paris: France, the Netherlands and Belgium have recorded 3,700 excess deaths during the June heatwave that sent temperatures soaring across Europe, with authorities warning that the numbers are preliminary and could rise.

Experts have said the heatwave, which lasted from about June 20-28, was the worst recorded in Europe, causing disruption to power generation, damaging infrastructure and overwhelming healthcare systems.

The extreme heat was almost certainly driven by climate change, scientists said.

There were 2,025 excess deaths recorded in France during the heatwave, with a particular increase in deaths among people aged 65 and older. French health minister Stephanie Rist told local television on Friday.

Deaths at home rose 91 per cent between June 22-28 compared to the previous week, while deaths in nursing homes and healthcare facilities also increased, the country's public health authority said in a bulletin. "Mortality will ... be higher than these initial figures suggest," the authority warned.

In Belgium, the health ministry said on Thursday it had registered excess mortality of about 1,200 deaths between June 18 and June 29, adding that 530 of the deaths were among people aged 65 or older. People aged under 65 accounted for 180 of the excess deaths.

"Such excess mortality during a heatwave is unprecedented in our country," the ministry said in a statement.

Authorities in the Netherlands said the heatwave led to about 480 excess deaths. Reuters
