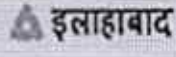

Mrs. Radha Devi W/o Mr. Ganpat Singh Rawat and Mr. Ganpat Singh Rawat S/o Mr. Babu Singh has availed **Housing loan facility** from Indian Bank, **Beawar Branch** and the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as "the Property". All of the concerned vis **Mrs. Radha Devi W/o Mr. Ganpat Singh Rawat and Mr. Ganpat Singh Rawat S/o Mr. Babu Singh** have failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **17.03.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of



Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **Mrs. Radha Devi W/o Mr. Ganpat Singh Rawat and Mr. Ganpat Singh Rawat S/o Mr. Babu Singh** liable to the Bank to pay the amount due to the tune of ₹ 20,95,204/- (Rupees Twenty Lakh Ninty Five Thousand two Hundred Four Only) as on 16.03.2026 plus further Interest along with charges and expenses thereon. You failed to make payment despite Demand Notice dated **17.03.2026**.

As **Mrs. Radha Devi W/o Mr. Ganpat Singh Rawat and Mr. Ganpat Singh Rawat S/o Mr. Babu Singh** failed to make payment despite Demand Notice, the Authorized Officer took symbolic possession of the schedule mentioned properties under the Act on **02.06.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE E-AUCTION MODE.

As per **Rule 8(6)** read with **Rule 9(1)** of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, **30 days'** notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **16.03.2026** is ₹ 20,95,204/- (Rupees Twenty Lakh Ninty Five Thousand two Hundred Four Only) plus further Interest along with charges and expenses thereon.

Please take note that this is notice of **30** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **30** days.

The date of sale is fixed as 28.10.2026 which would be by E-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **16.09.2026 to 27.10.2026** between **11.00 am to 4.00 pm on working days.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The terms and conditions of e-auction is available in the website(<https://baanknet.com>).

The intending Bidders/Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **27.10.2026** i.e before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.



Earnest Money Deposit (EMD) amount as mentioned above shall be paid online or after generation of Challan from the website (<https://baanknet.com>) (PSB Alliance Pvt. Ltd.) **for depositing in bidders EMD Wallet.** NEFT transfer can be done from any Scheduled Commercial Bank. Payment of EMD by any other mode such as **Cheques will not be accepted.** Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. The Earnest Money Deposit shall not bear any interest.

The Authorized Officer/Bank has the absolute right to accept or reject any bid or adjourn/postpone/ cancel the sale without assigning any reason therefore.

The successful bidder shall have to deposit 25% (twenty-five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of auction in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer.
